Keeping Youth Involved

Youth benefit from programs only if they remain engaged in them. The study of retention of older 4-H youth has many implications for those who work with young people, either as professionals or as volunteers, and for young people themselves.

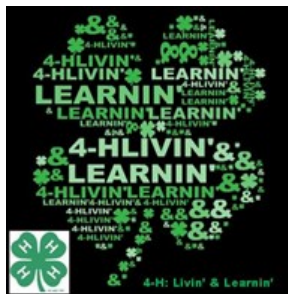
Club advisors are important to a young person's satisfaction with the 4-H program and their decision to reenroll or to discontinue their involvement. Moreover, their support is also what helps youth achieve desired outcomes. We must ensure our training prepares volunteers to provide a positive club experience for members.

Older youth desire challenging, meaningful roles and responsibilities. They lose interest if adults take over all of the leadership roles. On the other hand, youth need support to carry out leadership roles. Knowing when and how much support to provide is a balancing act for those working directly with youth.

Create intermediary leadership opportunities for youth who are 11 to 14 years to keep members engaged. Youth in this age group may need more support to assume these roles, and they won't develop the skills if they have no chance to practice them in a safe, supportive environment. Prior preparation for both participants and judges can ensure that good sportsmanship and the highest ethical standards of behavior are practiced. Furthermore, be sure that expectations and any "unwritten rules" for competitions are clearly stated. Develop ways to reward friendly cooperation, not just competition. Negative experiences with competition can lead youth to discontinue their membership in organizations. Furthermore, today's workforce values those who can work successfully in teams. Develop strategies that can help youth balance competing demands on their time and become successful in both 4-H and other activities, such as sports, the arts, and jobs.

Ultimately, our goal is to engage young people in ways that support their current development and help them transition to a productive adulthood. Let's be sure they stick around long enough for us to do that.

2016 SKILLATHONS

Project judging and skillathons allow youth to demonstrate and review what they have worked on and learned throughout their project year.

LOCATION: Washington County Fairgrounds Livestock Barn.

ALL livestock (market, dairy, breeding, fancy, and/or horse) project members are **required** to participate in skillathons for **each** specie project they have enrolled in. Skillathons are **required** for all livestock and horse project participants in order to remain 4-H members in good standing and be eligible to exhibit, participate, show and/or sell their project animals at all three fairs. FFA youth taking hogs and/or Feeder calves should contact their FFA teacher for project requirements and eligibility. FFA Youth are **Required to participate in skillathons** for all animals sold at the Washington County Fair. To help this process and coordinate efforts of youth and volunteers

ALL Skillathons will be offered:

Saturday August 6, 2016

8:30-11:30 - hogs, goats, lambs, rabbits (except pet rabbit);

12:30-3:30 - beef, dairy, poultry, horse (except horseless horse)

Make-up days: August 8 and 9 (noon-7:00 pm)
(limited space, calling to reserve an appointment is required--no make-up times will be available before August 8)

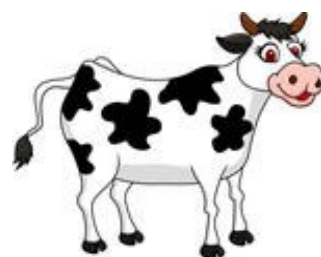

Tips for Judging Day

10. Have your project book completed before the day
9. Dress nicely (make a good first impression)
8. Prepare a poster board or binder with information, or bring a couple of “tools” you used to complete your project (you can later display this in your club’s booth at the fair)
7. Stay close to your materials, do not leave them unattended, accidents happen
6. Review your projects before judging day
5. Don’t be afraid of talking to the evaluators, they are interested to learn more about your project
4. Answer questions the best you can and if you don’t know something, just say so
3. Relax, everyone gets nervous
2. Take a deep breath and smile
1. Be yourself

Ohio State Fair Project Orientation July 15

4-H members who are selected to represent Washington County at the Ohio State Fair, should plan to attend the State Fair Orientation on July 15, 2016, 6:30pm at the Extension Office. This is a time for members, parents, and advisors to become familiar with State Fair judging, directions to judging venues, plus ideas on how to take projects to a new level for State Fair interviews and judging will be shared.

4-H members selected as State Fair representatives at County 4-H Project Judging will receive notification of their project judging day and time at the State Fair. If you are selected as a State Fair representative, it is very important for you to let the office know as soon as possible if you are able to participate. If you are able to participate, we need time to get you the details, tickets and maps you will need for your State Fair trip. If you are unable to participate we will need time to contact alternates. The Ohio State Fair can be an awesome experience for the whole family!

Going to the Ohio State Fair as a county representative can be a wonderful opportunity. It is a time to meet others from around the state, learn more about your project interest, and gain useful interviewing skills. Many 4-H’ers feel they are not ready or too nervous to take this opportunity but it can be a fun adventure filled learning experience. We hope the State Fair Orientation and encouragement from parents and advisors will give those members selected for State Fair the tools they need to take the adventure!

4-H Project Judging Guidelines



Members are responsible for the completion of their project and must Attend project judging to remain in good standing with 4-H.

Project Book: All members are required to purchase a project book for their project they have enrolled in for the current 4-H year and must bring the completed book to project judging.

Attend Project Judging:

- *Attend Judging at the Washington County Career Center June 28, 2016
- *Refer to 2016 Schedule in the June/July Newsletter for times
- *Make up Judging is scheduled for July 20th or 26th from 12 noon to 7pm. Call the Extension Office to schedule a time at 740-376-7431.
- *All Project Judging must be completed on the day of the event or on a scheduled make up day.

Project Requirements:

- *Bring project book with all required pages completed to judging.
- *Refer to the 4-H Project Requirements at <http://washington.osu.edu>
- *Arrive 15 minutes before your scheduled time to register / check in
- *Bring Education displays, visual aids or props
- *Dress should be business casual / or 4-H club shirts.

Registration Process:

- *Arrive 15 minutes before scheduled judging time
- *Check in at registration table
- *Volunteers will assist you in filling out score sheet
- *Be sure to write legibly on your score sheet and include name, age, club project name, and project number.

Judging Process:

- * Sign in at your interview room (Please include first and last name)
- *Please wait patiently for the judge to call for you outside the room.
- *You will be called by the judge individually for a 5-10 minute interview
- *If you have 2 projects at the same time, please make note on the sign in sheet, so the judge may go to the next person if you are unavailable
- *Wait outside the room and be ready when your name is called.

Score Sheet:

- *When you meet the judge, provide them with your score sheet
- *The judge will keep your score sheet until the end of the judging period
- *The judge will check out and give the volunteers the score sheets
- *Score sheets will be available for members to pick up at the judges check out table 1 hour after the judging period concludes.
- *If you do not pick up your score sheet, it will be given to your club advisor
- *Ribbons will be distributed at the fairs in the Club packets.

Ohio State Fair: A member attending the June 28, 2016 judging event and scoring a superior (90-100) on their project will be considered for State Fair eligibility. Please see the Family Guide to determine if your project is an eligible project for state fair. The judge will determine who is the State Fair participant and an alternate. If a member is selected for State Fair, they will be notified by mail or contacted by phone. If a selected member cannot attend state fair the alternate will be notified and given the opportunity to compete at State Fair. Members are also required to attend a State Fair orientation to receive information and tickets for State Fair.

What Happens at Fair?: Clubs will determine which fair they will display a booth. Members are encouraged to display their projects in their club booth and will receive a premium from the fair.

OHIO STATE FAIR SKILLATHONS

This year will be the debut of the first ever Ohio State Fair Skillathon Excellence awards. Youth must compete in ALL 9 SKILLATHONS and receive a MINIMUM score of 65% in order to be eligible for this award. The top 10 highest scoring individuals regardless of age division will receive belt buckles.

Top 3 individuals will be recognized at the sale of champions and will divide \$1000 from the Youth Reserve Program. We recognize this is quite an undertaking for youth and can be very expensive and time consuming. Youth who feel cost may be prohibited can contact me and arrange for passes to get into the fair. To be eligible for a pass youth must have competed in all Skillathons up to that point and have achieved the minimum score. It is our hope that these awards will encourage

youth to learn more about animal science and branch out from their particular species. Official rules will be located in the Skillathon rules posted on the Ohio State Fair website (<http://ohiostatefair.com/livestock/>).



Trash Can Painting Contest

Trash cans should include your group's name and the year 2016. Trash cans will be judged on creativity, neatness, and overall appearance. This contest is open to all 4-H Clubs, FFA and FCCLA Chapters, and Girl Scout and Boy Scout Troops.



Washington County Fair: Go to Washington Co. Fair Grounds after July 20 and pick up a trash can to paint. When the can is completed, please make sure you bring it, along with a completed entry form, to the Junior Fair Office by 9:00pm, Thursday, September 1.

Barlow Independent Fair: Go to the Barlow Fairgrounds and pick up a trash can in the dairy barn. Painted cans should be dropped off at the Jr. Fair Building on September 21 by 8:00 pm with the completed entry form.

➔ Members whose last name falls between letters A to K will need to attend Pen set up on Aug. 14 at 3pm.

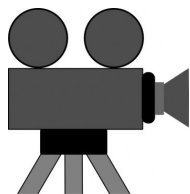
➔ Members whose last name falls between letters L to Z need to attend Pen tear down on Sept. 11 at 3pm.

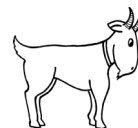

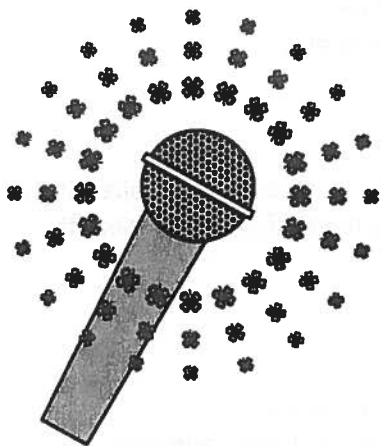

Guidelines for Illustrated Talk or Demonstration WITHOUT use of Computer Technology: Junior & Intermediate Divisions

- Judges will evaluate all Demonstrations and Illustrated Talks using the following criteria: appearance, introduction, delivery, content, conclusion, materials, and personal interview with the participant(s).
- Presentations, whether given by an individual or a team, should last between 6 and 9 minutes, with four points deducted for times over or under. Contest participants are welcome to ask audience members if there are any questions after the demonstration has concluded. Any time used to ask or answer questions after a demonstration has concluded will not be considered part of the actual demonstration time.
- A team demonstration will consist of two people sharing the speaking and teaching role. When members of a team fall into different age categories, they will participate in the older member's division.
- A member or team may select any topic for his or her demonstration or illustrated talk, except for those noted under guideline #7 below.
- The presenter can use appropriate props and other visual aides to teach others about a subject or how to do something. The topic, materials, and posters should be selected and prepared by the 4-H member. Topics, materials and posters previously used by someone else in another demonstration should not be utilized. No PowerPoint or computer generated messages can be used for this contest.
- Two easels and a table will be available for use by participants in each demonstration area upon request.
- Firearms, bows, arrows, and weapons are not permitted in the Demonstration Contest and may not be used in a 4-H demonstration or illustrated talk. Plastic or wooden replicas are permissible.
- Contest divisions will be: Jr. Individual (Age 8-11 as of January 1 of Current Year); Jr. Team (Oldest Team Member is Age 8-11 as of January 1 of Current Year); Intermediate Individual (Age 12-13 as of January 1 of Current Year); Intermediate Team (Oldest Team Member is Age 12-13 as of January 1 of Current Year)

Guidelines for Illustrated Talk or Demonstration WITH the use of Computer Technology: *Intermediate and Senior Divisions*

1. Judges will evaluate all Demonstrations and Illustrated Talks using the following criteria: appearance, introduction, delivery, communication skills, content, conclusion, materials, and personal interview with the participant. The member(s) will also be evaluated on their ability to effectively use technology, if applicable, within their presentation.
2. Presentations should last between 9 and 12 minutes, with four points deducted for times over or under. Contest participants are welcome to ask audience members if there are any questions after the demonstration has concluded. Any time used to ask or answer questions after a demonstration has concluded will not be considered part of the actual demonstration time.
3. A team presentation will consist of two people sharing the speaking and teaching role. When members of a team fall into different age categories, they will participate in the older member's division.
4. The presenter(s) can use appropriate props and/or computer generated visual aides to teach others about a subject or how to do something. Use of computer generated visuals is NOT required. Examples:
 - *A Demonstration may be delivered in this category. PowerPoint type technology *may be added* in addition to other props to help present the message.
 - *An Illustrated Talk may be delivered in this category with member(s) using PowerPoint type technology to present all or part of the visual message; *must be* accompanied by live narration.
5. Requires live speech delivered along with the PowerPoint or poster message. (No pre-recorded narration)
6. Contest divisions will be:
 - Intermediate Individual (Age 12-13 as of January 1 of Current Year)
 - Intermediate Team (Oldest Team Member is Age 12-13 as of January 1 of Current Year)
 - Senior Individual (Age 14 and up)
 - Senior Team - not judged at state fair

4-H Pledge Contest

Participants must be ages 8-11 as of January 1st of this year. Judges will evaluate participants based on Voice, Stage Presence, Power of Expression, and General Effect. When reciting the pledge, use correct hand movements.

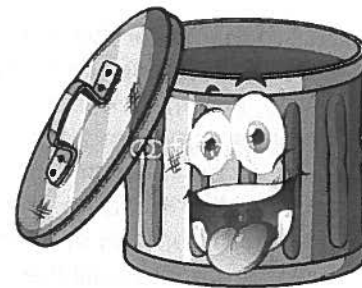
OHIO STATE FAIR SKILLATHONS

This year will be the debut of the first ever Ohio State Fair Skillathon Excellence awards. Youth must compete in ALL 9 SKILLATHONS and receive a MINIMUM score of 65% in order to be eligible for this award. The top 10 highest scoring individuals regardless of age division will receive belt buckles. Top 3 individuals will be recognized at the sale of champions and will divide \$1000 from the Youth Reserve Program. We recognize this is quite an undertaking for youth and can be very expensive and time consuming. Youth who feel cost may be prohibited can contact me and arrange for passes to get into the fair. To be eligible for a pass youth must have competed in all Skillathons up to that point and have achieved the minimum score. It is our hope that these awards will encourage youth to learn more about animal science and branch out from their particular species. Official rules will be located in the Skillathon rules posted on the Ohio State Fair website (<http://ohiostatefair.com/livestock/>).

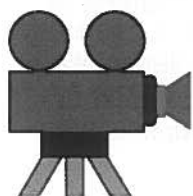

Planning a 4-H Cloverbud Family Night

I woke up one morning thinking, "What if little kids were the only ones in the world who could drive?" They would own big clunky cars that would only go about 10 miles an hour and parents would have to ask them for rides to get places. When I thought about it later, I decided that 4-H Cloverbud meetings would probably be better attended. They would have a chance to see their friends. Doctors' offices and grocery stores would probably struggle to survive. Well, anyway, it was just a dream.

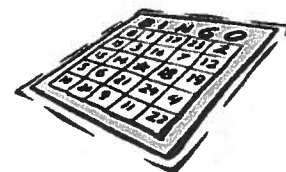
The fact is- Cloverbuds depend on their parents to get them to our meetings. When they miss, it probably isn't their fault. Parents probably had to put something else first- work, the grocery store, banking, etc. What can we do as Cloverbud advisors to move our meetings up the ladder of importance in our parents' minds? I suggest a Family Night event early in the year so parents can see why their Cloverbuds need to be at the meetings.



A Family Night event does not have to be difficult. I would suggest 4-5 activities that families can do together at their own pace. I would also suggest a short session where everyone could meet together as a group. Your activities may include a story, a craft, a game, a snack, and maybe a song or two. Another idea is to present the parents with an overview of the lessons you will be teaching during the upcoming months and why they won't want their children to miss out on a single one.

I would also be sure to allow time for parents to have time to meet and talk to each other. This could be helpful on meeting dates when parents can't get their Cloverbuds to a meeting. Parents may want to discuss car pool ideas to make it easier for everyone to get there.

One game idea for the evening is a Family Bingo game. (The Bingo card is included with this article.) Allow parents some time to go through the card with their Cloverbuds to see how many squares they can answer. Then bring all the families together to share what they've learned. They may find things they have in common with other families and form friendships based on those commonalities. Family friendships will make our clubs stronger.



Throughout the event, be sure that parents realize that 4-H Cloverbuds is about building life skills including self-understanding, social interaction, learning to learn, physical mastery, and decision-making. Each activity should reinforce at least one of these life skills.

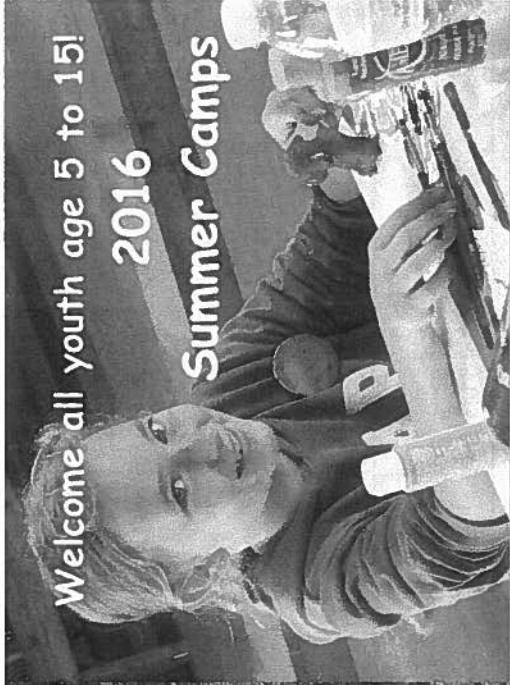
